RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

IN CONSIDERATION of being permitted to enter ***for the purpose of participation of the activities associated with the motorized bucking machine***, or for any purpose to enter any RESTRICTED AREA (herein defined as including but not limited to the motorized bucking machine along with all aspects associated with said machine, arena, chutes, staging area, approaches thereto and all walkways, concession, and other areas appurtenant to any area where any activity related to the event shall take place), or being permitted to compete, officiate, observe, work for, or for any purpose participate in any way in the event, THE UNDERSIGNED, for himself/herself, his/her personal representative, heirs, and next of kin, acknowledges, agrees and represents that he/she has or will immediately upon entering any of such restricted area or areas and his/her participation, if any in the event constitutes an acknowledgment that he/she is in or about restricted areas and if he/she further agrees and warrants that if, at any time, he/she is in or about restricted areas and if he/she feels anything is unsafe, he/she will immediately advise the staff of such and will leave the restricted areas.

1. I/WE HEREBY RELEASE, WAIVER, DISCHARGE, COVENANT NOT TO SUE the WILDERNESS ASSOCIATION OF COWBOY CHURCHES, the SOUTH EAST IDAHO RODEO BIBLE CAMP, INC. staff, Board of Directors, the operator of the motorized bucking machine, promoters, participants, rodeo association, sanctioning organization or any subdivision thereof, arena operator, arena owner, officials, or their

participants, any persons in restricted area, promoters, sponsors, advertisers, stock contractors, owners, lessee of premises used to conduct the event and each of them, their officers and employees, all for the purpose therein referred to as "Releasees" from all liability to the undersigned my/our personal representatives, assigns, heirs and next of kin for any and all losses or damage and any claim or any demand on account of any injury to the participant included, but not limited to, death whether caused by the negligence of the "Releasees" or otherwise while the minor is in or upon the restricted area and/or competing in, observing, working for or any purpose participating in the event.

2. I/WE HEREBY ACKNOWLEDGE, that the "Releasees" as well as the activities and events conducted, supervised, or in any way connected with "Releasees" are protected by Idaho's EQUINE ACTIVITIES IMMUNITY ACT and are therefore protected under STATUTORY IMMUNITY and are not subject to legal sanction or liability connected therewith.

3. Each of the undersigned parent(s) or legal guardian(s) of the minor participant HEREBY AGREES TO INDEMNIFY AND SAVE AND HOLD HARMLESS the "Releasees" and each of them from any loss, liability, damage or cost they may incur due to the presence of the said minor in or upon the restricted area or in any way competing, officiating, observing, or working for any purpose participating in the event and cause by the negligence of the "Releasees" or otherwise.

4. I/WE HEREBY AGREE FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH, PROPERTY DAMAGE due to the negligence of "Releasees" or otherwise in or upon the restricted area or areas and/or while competing, officiating, observing, or working for or any purpose participating in the event.

5. The undersigned expressly acknowledge and agree that the activities of the event are very dangerous and involve risk of serious injury and/or property damage.

I/WE, THE UNDERSIGNED, EXPRESSLY ACKNOWLEDGE AND AGREE that the activities of the event are very dangerous and involve the risk of serious injury and/or death and/or property damage and I/WE, THE UNDERSIGNED, further expressly agree that the foregoing release waiver and indemnity agreement is intended to be as broad and inclusive as it is permitted by the law of the State of Idaho and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

ASSUMPTION OF RISK

I/WE have discussed the event(s) that the participant wishes to participate in and have explained the possibility of being slightly and/or severely injured. I/WE are willing to assume the responsibility of possible injury that could result from the event in which the participant will be participating.

I/WE further agree and have explained to the participant that should the participant feel endangered at any point, either by their own actions, the actions of others, or by any surrounding circumstances that the participant is free to withdraw from the event, and will do so of their own free will.

I/WE AND THE PARTICIPANT are voluntarily foregoing our legal rights against the Wilderness Association of Cowboy Churches and the South East Idaho Rodeo Bible Camp and voluntarily assume the risk inherent to this event and that I/WE AND THE PARTICIPANT do so of our own free will.
